# Textbook

Jack Lee, Riemannian Manifolds: Introduction to Curvature

## **Course Description**

The purpose of this course is to introduce fundamental topics in Riemannian Geometry such as tensors, vector bundles, Riemannian metric, Levi-Civita connection, Riemann Curvature tensor, geodesics and geodesic distance. Additional topics might be chosen based on students' interests.

## **Determining Course Grade**

A letter grade for the course will be determined by: HW 55%, Lecture Notes 40%, Commenting 5%

If a student is taking the course Pass/Fail:

Option 1: to receive Pass need 65% or more from the above letter grade breakdown.

Option 2: Type three lectures and participate at a successful level (4-5 grade for presentation, see below) in three problem sessions OR type two lectures and participate at a successful level (4-5 grade for presentation) in four problem sessions.

## Homework/Problem Sessions

Homework will be posted in the shared folder and discussed in class during a Problem Session, which will usually be on Mondays, every two weeks.

A student will be randomly picked to present a problem, but for some problems we will allow volunteers. Everyone will have to present at least three times during the semester with a possibility of presenting up to 8 times. The presentation will be graded on a scale from 0 to 5.

During the presentation, everyone is encouraged to ask questions and make comments. In addition, one student will be chosen to "officially" comment on the solution. There will be no grade for the commenting: just Pass/Fail. Each student will be chosen to comment between 1-8 times.

When chosen to present or comment, but absent from class, a student will receive a grade of 0. One lowest grade will be dropped for both presenting and commenting.

#### Lecture Notes

We will follow an alphabetical order. Students will type notes for each lecture. The student will have a week to type and submit the notes by 5pm to a shared folder. The notes will be graded on a scale from 0 to 10. One point will be subtracted for each day the notes are late. The student can use whichever template they like, but the notes must include the lecture's number and date. If the due date falls on a day of a Problem Session, the due date will be moved to the next lecture day, still by 5pm.
