Midterms: There will be 3 evening exams during the semester on February 3, March 3, and April 7 at 5:15pm. If you miss an exam and there is not a valid excuse, you will receive a zero for that exam grade. If you miss an exam and there is a valid excuse, we will compute your grade from the rest of the data that we have.

**Final:** There will be a comprehensive final exam given on May 5 at 10:30am. The final cannot be taken at an alternate time, so mark your calendar. You will not be excused from the final exam because of travel.

WeBWorK Problems: There will be problem sets assigned from each section of the text. The problems will be due regularly as the material is covered in lecture. See WeBWorK for specific due dates. Late homework will not be accepted for any reason.

Written Problems: There will be problem sets assigned from each section of the text. The problems will be collected weekly on Monday, with the exception of the first set that will be collected on Tuesday, due to the holiday. These written assignments will require clear and complete answers using full sentences and appropriate mathematical notation. Late homework will not be accepted for any reason. We will drop 2 homework assignments.

**Recitation Worksheets:** There will be a worksheet administered in recitation each week. Half of the grade on each worksheet will be based on in-class participation in groups. The other half of the grade will be based on correctness of results. If you are unable to attend recitation, you will be allowed to submit the worksheet with homework on the following Monday for half-credit only. We will drop 2 worksheets.

**In-class Participation:** At the discretion of your instructor, you may be asked to present problems at the board, work in groups on projects, or other activities during class. This component of your grade will reflect your effort in the participation of these events.

#### **GATEWAY EXAM**

There will be a short exam called a gateway exam that is graded as pass or fail. The exam will focus on techniques of integration and will be given in class on February 12. If a student does not pass the exam on this first attempt, then arrangements must be made with their instructor for a second attempt. If the student does not pass this gateway exam, their course grade will be lowered by one full letter grade.
