Prerequisites: Math 2001 (Introduction to Discrete Mathematics), or the equivalent

Text: *Analysis, With an Introduction to Proof*, S.R. Lay, Pearson - Prentice Hall, 2014, 5th edition. After a quick review of Chapters 1 and 2, we will cover most of Chapters 3–7.

Course outline: This course is meant to familiarize the student with the rigorous theory behind the study of functions of a single real variable, and goes over the proofs of some of the major results used in calculus. Topics to be covered include: the topology and order structure of the real line; sequences of real numbers and limits of sequences; functions of a real variable: limits of functions at a point, continuous functions and their properties – Intermediate Value Theorem, uniform continuity; the derivative of a function at a point and differentiability, the Mean Value Theorem; the Riemann integral and its properties, and the Fundamental Theorem of Calculus.

Grading: Grades will be based on two in-class midterms (22.5% each), weekly homework assignments consisting of problems from the text (20%), in-class activities (5%), and a comprehensive final exam (30%). You are allowed to work together on homework, although each student must upload an individual write-up to Canvas by the due date. Homework will usually be due uploaded to Canvas on Fridays at 11:59 p.m., and late homework will not be accepted.

Midterm 2: Wednesday, November 8, 2023, during class-time;
FINAL EXAM: Wednesday, December 20, 2023, 7:30 p.m. – 10:00 p.m. (yes, the very **last** exam session), note the evening hour.

THERE WILL BE NO MAKE-UP EXAMS, so make sure now that you have no conflicts!

Friendly advice:

- **Attend class and ask questions.** Things will often be said in class that are not covered in the text, and participating in classroom discussions is an important part of the learning process. **I am blind in my left eye, so if you sit on that side of the classroom, please speak up and tell me “I have a question!!” because I cannot see raised hands on that side!**

- **Read the book.** The text is intended to be read *in addition to* classroom lectures, and it contains many more details and examples than are possible to cover in lectures.
- **Do the homework.** Not only does it count for a significant portion of your grade, but this is one of the best ways to study and learn.
- **Come to my office hours.** I am happy to help you with the homework, or discuss anything we've done in class.
