# Math 6310: Introduction to Real Analysis I Fall 2022

Prerequisites: Math 3001 and Math 4001 (Analysis 1 and Analysis 2), or the equivalent

**Text:** Real Analysis, H.L. Royden, P.M. Fitzpatrick, Prentice Hall, 2010, 4th edition. We will cover most of Chapters 2–7, and more if time permits. The book Real Analysis, Modern Techniques and Their Applications, Gerald B. Folland, John Wiley and Sons, 1999, Second Edition, is also a good reference.

Course outline: This course is meant to familiarize the student with the analysis of functions of a single real variable, with an emphasis on Lebesgue measure and Lebesgue integration on the real line, together with their relationship to differentiation. Topics to be covered include: the historical development of the Lebesgue integral, a review of set theory, the structure of open sets and Borel sets on the real line, Lebesgue outer measure on  $\mathbb{R}$ , Lebesgue measurable subsets of  $\mathbb{R}$ , Lebesgue measurable extended real-valued functions, definition of the Lebesgue integral, convergence theorems in Lebesgue integration, functions defined by integrals and convolution, diffentiation of monotone functions, functions of bounded variation, absolute continuity, review of metric space theory,  $L^p$  spaces, the Arzela-Ascoli Theorem, and if time permits, the Stone-Weierstrass Theorem.

**Grading:** Grades will be based on two in-class midterms (20% each), homework assignments assigned every two weeks or so during the course of the semester, consisting both of problems from the text and other problems (30% - sometimes I will ask for solutions to be presented during class) and a comprehensive final exam (30%). Late homework will not be accepted.

#### Test and exam dates:

Midterm 1: Wednesday, September 28, 2022 in class;

Midterm 2: Wednesday, November 2, 2022, in class;

FINAL EXAM: Wednesday, December 14, 2022, 1:30–4 p.m., in class. By University requirements, we must have the final exam on this date and at this time.

THERE WILL BE NO MAKE-UP EXAMS, so make sure now that you have no conflicts!

### Homework and in-class presentations:

• Assignments consisting of problems from the text and other sources; these assignments will focus on learning the mathematical content of the course. You will usually have two week to do these problems, which will cover material studied the previous two weeks. Homework solutions will be due uploaded to Canvas by 11:59 p.m. on the due date. Because of the holiday Monday September 5, 2022 (Labor Day), the days of the week that the homework is due will vary through the semester. Some, but not all, of these problems will be graded. I will occasionally ask students to present homework problems on the board. Handing in solutions to assigned homework that have been copied verbatim from the internet or Chegg.com or any other homework-solution-providing website is a violation of the Honor Code, and violations will be reported to the Honor Council.

You are encouraged to work together on homework, although each student must submit an individual write-up. Late homework will not be accepted.

## Friendly advice:

- Attend class. Things will often be said in class that are not covered in the text, and participating in classroom discussions is an important part of the learning process.
- **Read the book.** The text is intended to be read *in addition to* classroom lectures, and it contains many more details and examples than are possible to cover in lectures.
- **Do the homework.** Not only does it count for a significant portion of your grade, but this is one of the best ways to study and learn.
- Come to my office hours. I am happy to help you with the homework, or discuss anything we've done in class.
