#### **Targeted Audience and Prerequisites:**

The course is intended for graduate students in mathematics or physics with an interdisciplinary interest.

Some basic knowledge of differential geometry and quantum physics is recommended for participation in the course.

**Course Contents:** The course will provide an introduction to the geometric description of quantum field theories. Topics include symplectic mechanics and deformation quantization, classical field theory within the jet bundle formalism, lorentzian geometry, symmetries in quantum mechanics, axioms of a quantum field theory and an outlook to mathematical approaches for rigorous constructions of perturbative and non-perturbative quantum field theories.

Homework and exams: Homework assignments will be given on the course homepage. Every student needs to present some homework problem in class.

**Course Project:** In addition to the homework, each student has to work on a course project and write a short paper (around 5 pages) which will be presented in class. A selection of possible topics will be provided on the course page, but you can propose your own project.

Course Grading: Your grade will be determined from the talk and the course project.
