# Math 8370: Harmonic Analysis 1 Fall 2024

Prerequisites: Math 6320 (Introduction to Real Analysis 2), or instructor consent.

**Text:** A First Course in Harmonic Analysis, Anton Deitmar, Springer Verlag, 2005, second edition. This book is available in electronic form from the CU library.

Course outline: The material to be covered includes all of Chapters 1, 2 and 3 of the Deitmar book and much of Chapters 6, 7, 10 or 11, depending on student interest. Topics to be covered include: A review of periodic functions on  $\mathbb{R}$  relating them to functions on the unit circle  $\mathbb{T}$ , trigonometric polynomials and Fourier series on the circle, including convergence problems for Fourier series on  $\mathbb{T}$ , including convergence in  $L^1$  and  $L^2$ ; mean, pointwise and absolute convergence. Convolution in  $L^1(\mathbb{T})$ . The Fourier Transform in  $L^1(\mathbb{R})$ : convolution in  $L^1(\mathbb{R})$ , approximate identities and the Poisson summation formula. The Fourier transform in  $L^2(\mathbb{R})$ , inversion and the Plancherel Theorem; the Poisson Summation formula. Depending on student interest we might cover one or more of the following topics: Theta series, Fourier analysis on locally compact abelian groups and Pontryagin duality; representation theory for the matrix group SU(2), and/or representation theory for the Heisenberg group.

**Assessment:** Grades will be assigned on homework assignments (40 %), attendance and participation in terms of presentation of homeowork problems (10 %) and a project (oral and written) (50 %), due towards the end of classes.

**Homework:** 40 % of your final grade will be come from your performance on homework, which will be assigned every two and a half weeks or so. You are allowed to work together on homework, although each student must upload an individual write-up to Canvas by 11:59 p.m. of the due date. Late homework will not be accepted, and I will drop your lowest homework score. I will also drop the lowest problem score out of each homework.

Attendance and Homework participation: 10 % of your final grade will be come from your attendance and participation in class and in presenting homework, which will be assigned every two weeks to three weeks or so. It is an important part of the learning process to take part in these discussions and homework presentations. I am blind in my left eye, so if you sit on that side of the classroom, please speak up and tell me "I have a question!!" because I cannot see raised hands on that side!
